Pecuniary interests required to notify to Monitoring Officer under section 30 of the Localism Act 2011 and the other interests that require disclosure under the council's Code of Conduct :

- a. Any employment office, trade profession or vocation carried on for profit or gain
- b. Sponsorship - Any payment or provision of any other financial benefit (other than from the authority) made or provided within the previous 12 months in respect of any expenses incurred by you in carrying out your duties as a member or towards your election expenses - this includes any payment or financial benefit from a trade union.
- c. Securities - Any beneficial interest in securities of a body which has a place of business or land in the authorities area and in which you either have a beneficial interest in a class of securities of that body that exceeds the nominal value of £25,000 or one hundredth of the total issued share capital of that body.
- d. Contracts - Any contract between you and the authority for goods, services or works to be provided or executed and which has not been fully discharged

- e. Land - Any land in which you have a beneficial interest which is in the area of the authority
- f. Corporate tenancies - Any tenancy where the landlord is the authority and tenant is a body in which you have a beneficial interest.
- g. Licences - Any licence to occupy land in the authority's area (alone or jointly with others) for 28 days or longer

Other interests required to be disclosed under the Council's Code of Conduct 2020.

membership or position of general control or management in any -

- a. Body to which the members has been appointed or nominated by the authority as its representative
- b. Public authority or body exercising functions of a public nature.
- c. Body dedicated to charitable purposes
- d. Body whose principal purposes include the influence of public opinion or policy.

Membership of any :-

- a. Private club or society
- b. Any organisation which promotes secrecy amongst its members

Additional Notes

A member must within 28 days of becoming aware of any change to the interests specified above, provide written notification to the authority's monitoring officer of that change.

Failure to do so would be a breach of the code. Failure to register or to disclose at any meeting of the authority at which it arises any disclosable pecuniary interest is also an offence for which you may be liable to conviction.
