

MINUTES of the **MEETING** of **SILKSTONE PARISH COUNCIL** held on **Monday 4 June 2018** at Silkstone Sports Pavilion.

PRESENT

Meeting Chaired by: Cllr Meryl Liddell

Councillors: Richard Bell, Richard Leech, Derek Liddell, Debra Smith, Ron Stier and Alan Thompson.

In attendance: Parish Clerk, Ward Councillor Robert Barnard and Barnsley Chronicle reporter.

PUBLIC QUESTION TIME

A resident reported that the red areas of the calming scheme in Silkstone Common need attention – Cllr Barnard will report to Barnsley MBC Highways

The large pot hole at the Silkstone Common cross roads has not yet been filled in – Cllr Barnard to follow up with Barnsley MBC Highways

There was a query over whether the hedge at the top of Cone Lane has been cut back. This will be checked and reported to Barnsley MBC if necessary.

The village signs coming into Silkstone Common are very dirty (especially near Silverwood camp) Cllr Barnard will report.

Two areas of Japanese Knotweed in Silkstone Common have been reported to Barnsley MBC.

It was noted that it is unlikely that the blocked up post box in a wall on Moorend Lane will be replaced with a freestanding post box.

A resident who litter picks Cone Lane advised that the litter now frequently includes glass bottles and cans.

Cllr Liddell advised that 2 youths had been reported creating a cycle track in Jays Wood. Cllr Liddell had spoken with them. The issue has been reported to CARE who will monitor the wood.

Cllr Leech advised that the steps from Towngate to Manor Park have not been repaired.

Cllr Leech advised that the dog waste bin on Towngate, Silkstone was not emptied for two weeks. It was noted that the dog bin near the old mission rooms in Silkstone Common is also often missed – Clerk to highlight to Barnsley MBC.

It was noted that the vegetation on the A628 needs cutting back – Clerk to advise Barnsley MBC.

The response from Barnsley MBC relating to inconsiderate parking was noted – the advice is that inconsiderate parking should be reported to the Police to action.
