

**MINUTES of the MEETING of SILKSTONE PARISH COUNCIL held on Monday
4th March 2019 at Silkstone Sports Pavilion.**

PRESENT

Meeting Chaired by: Cllr Meryl Liddell.

Councillors: Richard Leech, Derek Liddell, Debra Smith, Ron Stier, and Alan Thompson.

In attendance: Cllr Robert Barnard (BMBC), Sheila Webber (Barnsley Chronicle reporter), Peter Milla (invitee)

PUBLIC QUESTION TIME

No resident issues raised so the Chair invited councillors to give reports.

Cllr Thompson reported that there had been problems with the garages on Martin Croft. Cllr Barnard suggested contacting Berneslai Homes. Cllr Thompson also reported tree removals around the Waggonway which would appear to be part of the planning permission.

Cllr D Liddell again reported an issue with the hedge at 1 Woodland View at the junction with Knabbs Lane is encroaching onto the footway and needs to be cut back. Clerk to report to BMBC. Cllr D Liddell also reported continuing issues relative to 'For Sale' signs adjacent to Stonecroft Court which were taken down but have now gone back up. Clerk to contact the Estate Agents.

Cllr Stier reported overhanging hedges intruding upon the highway at numbers 1, 3, 5 & 8 Moorend Lane. Cllr Stier also raised concerns about the new Royal Mail post-box which has now been opened but has no collection times; residents may have posted letters which are not getting collected. Clerk to again contact Royal Mail.

Cllr Leech again raised concerns about blocked gullies on the A628 and Cone Lane. He also advised that a chestnut tree behind the bus stop on A628 Silkstone Cross is still showing signs of disease, and although it has been reported to BMBC it has since deteriorated. Clerk to report to Highways again. Cllr Leech also reported street lights still being inoperative around The Cross and will obtain LC numbers. The pavement between Silkstone Primary School and the Red Lion Public House is in a bad state; also a pothole at the junction of Towngate and Huskar Close.

Cllr Leech also reported fly tipping on Silkstone Lane on the Bridleway just on Cawthorne side of the Bridge. The Waggonway opposite Tom Horsfield's has had road scalplings put upon it which must be removed; it appears that it may be part of the construction works. Clerk to action.
