

DRAFT MINUTES of the **MEETING** of **SILKSTONE PARISH COUNCIL** held on **Monday 3rd June 2019** at Silkstone Sports Pavilion.

PRESENT

Meeting Chaired by: Cllr Meryl Liddell

Councillors: Derek Liddell, Ron Stier, Alan Thompson and Peter Millar.

In attendance: Parish Clerk, Barnsley Chronicle reporter and one resident.

PUBLIC QUESTION TIME

Cllr M Liddell asked the Council to pay respects to Mr Edward Grey who sadly passed away recently; Ted Grey previously carried out duties as Silkstone Parish Clerk and was a member of the Scouting movement at Silverwood. Our thoughts go to family and friends.

Jim Ritchie of The Roggins heritage group addressed the Council concerning the Waggonway; which is mentioned in their Constitution as being of historical significance to the Parish. Mr Ritchie has sought a quotation from Groundwork to bring the section near Norcroft Bridge to a condition it was when first rescued many years ago. The quotation is for just under £850 + VAT and so the Roggins group are seeking financial assistance from the Parish Council. They may be able to contribute about £350 towards the cost. Once the work had been completed, the ongoing maintenance of the site could be done by CARE who are happy to take this on.

Cllr M Liddell thanked Mr Ritchie and suggested that the best way forward was for the Council to formally consider the financial assistance request at the next meeting scheduled for 1st July 2019 to which Mr Ritchie and possibly a representative of CARE are welcome to attend and present.

Members reported the following issues:

Cllr Stier reported that footpath Number 8 coming on to Cone Lane is very overgrown and almost impassable. Clerk has previously requested assistance from TWIGS and will remind. The verge grass outside house number 50 on Moorend Lane at the junction with Hall Royd Walk appears to have been missed by Barnsley MBC grass cutting team. Also reported was that the Royal Mail post box is now fully operative albeit with no collection times showing.

Cllr Thompson reported that a bench just outside Silkstone Primary School appears to have been vandalised. This may not belong to the Parish Council so will need to be checked against the bench asset list. The issues with the grass not being cut in the football play area on Broad gates have now been resolved by Cllr Thompson liaising with Barnsley MBC grass cutting team. There are ongoing Anti-Social Behaviour issues relative to any area of Martin Croft.

19-098 SILKSTONE RECREATION GROUND

RESOLVED to note that the plumber has not attended in relation to the changing room heater and that the part required for the emergency lighting has not arrived. Clerk to contact plumber and electrician.

Cllr Stier reported many issues that will be addressed at the next Silkstone Playing Fields Committee meeting on Monday 17th June 2019. Issues include lights left on, window open (behind shutter) rubbish left and generally dirty.

Cllr M Liddell said that if it was unacceptable mess the Council would charge cricket users for the additional handyman time and that if users did not treat the Pavilion with respect they would be stopped from having access.

19-099 FOOTBALL GOALPOSTS

RESOLVED to note that SUFC have gifted two mobile goal posts to the Parish Council which will be added to the Council's insurance schedule on the condition that SUFC moves the posts to a more secure site. The current storage of one goal post by chain to a private fence, trespassing on a public footpath and causing car parking issues is unacceptable.

RESOLVED to note that three meetings need to be scheduled in prior to the event and volunteers need to be engaged. Clerk to meet with Cllr M Liddell to co-ordinate.
